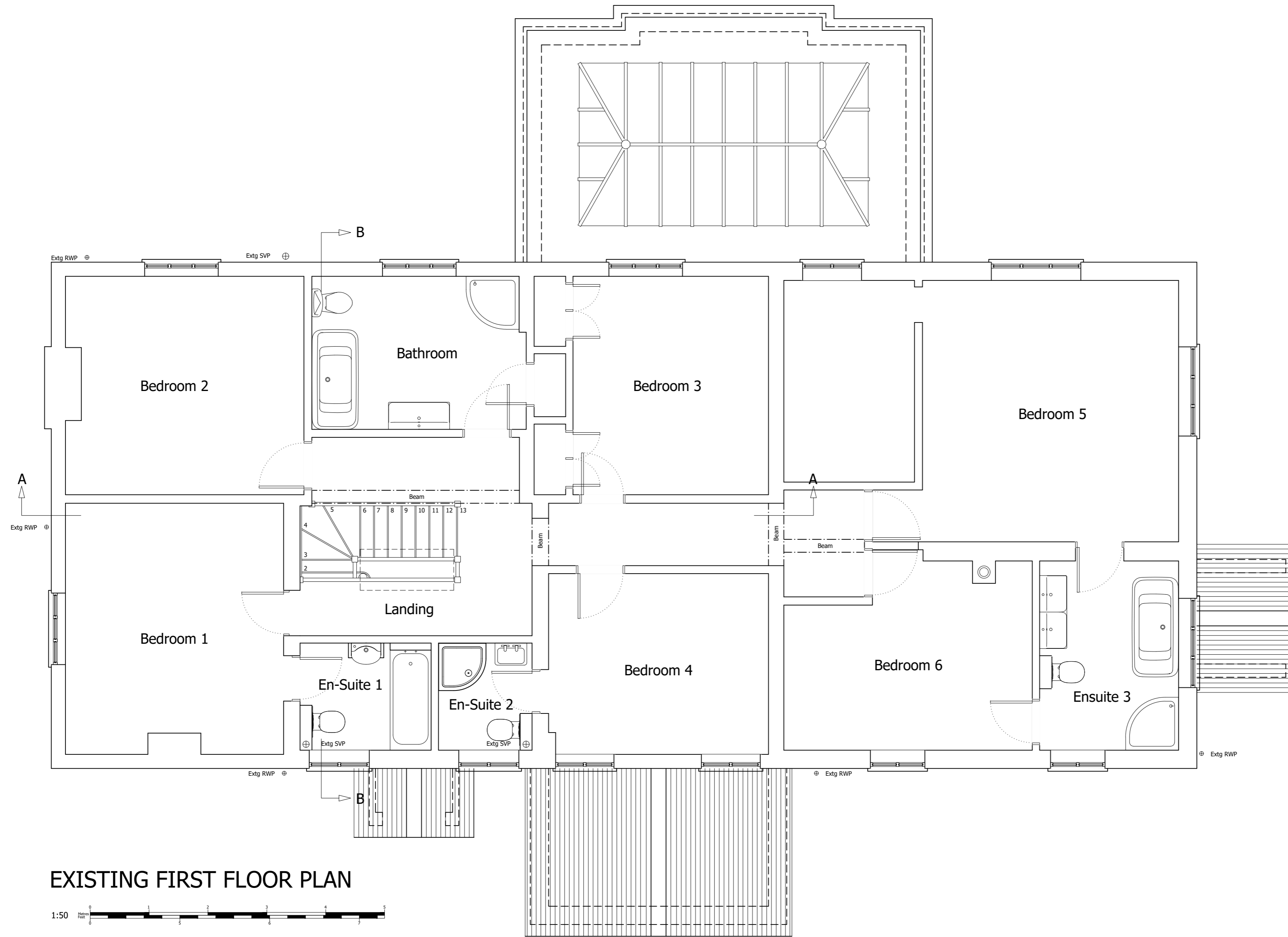

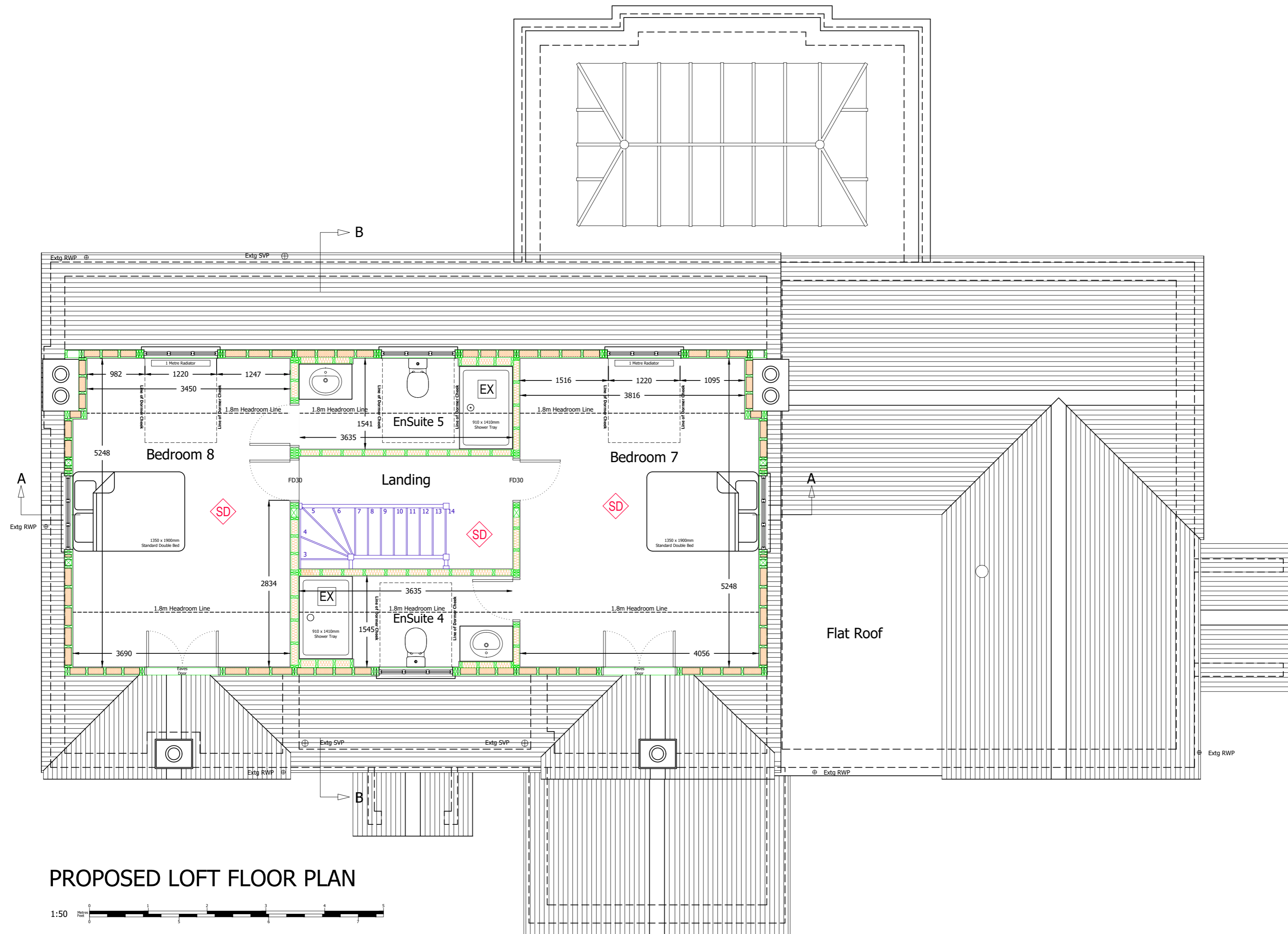
PROPOSED FIRST FLOOR PLAN



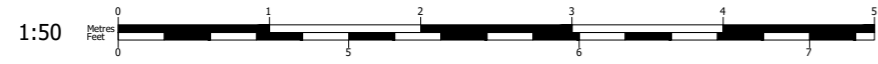

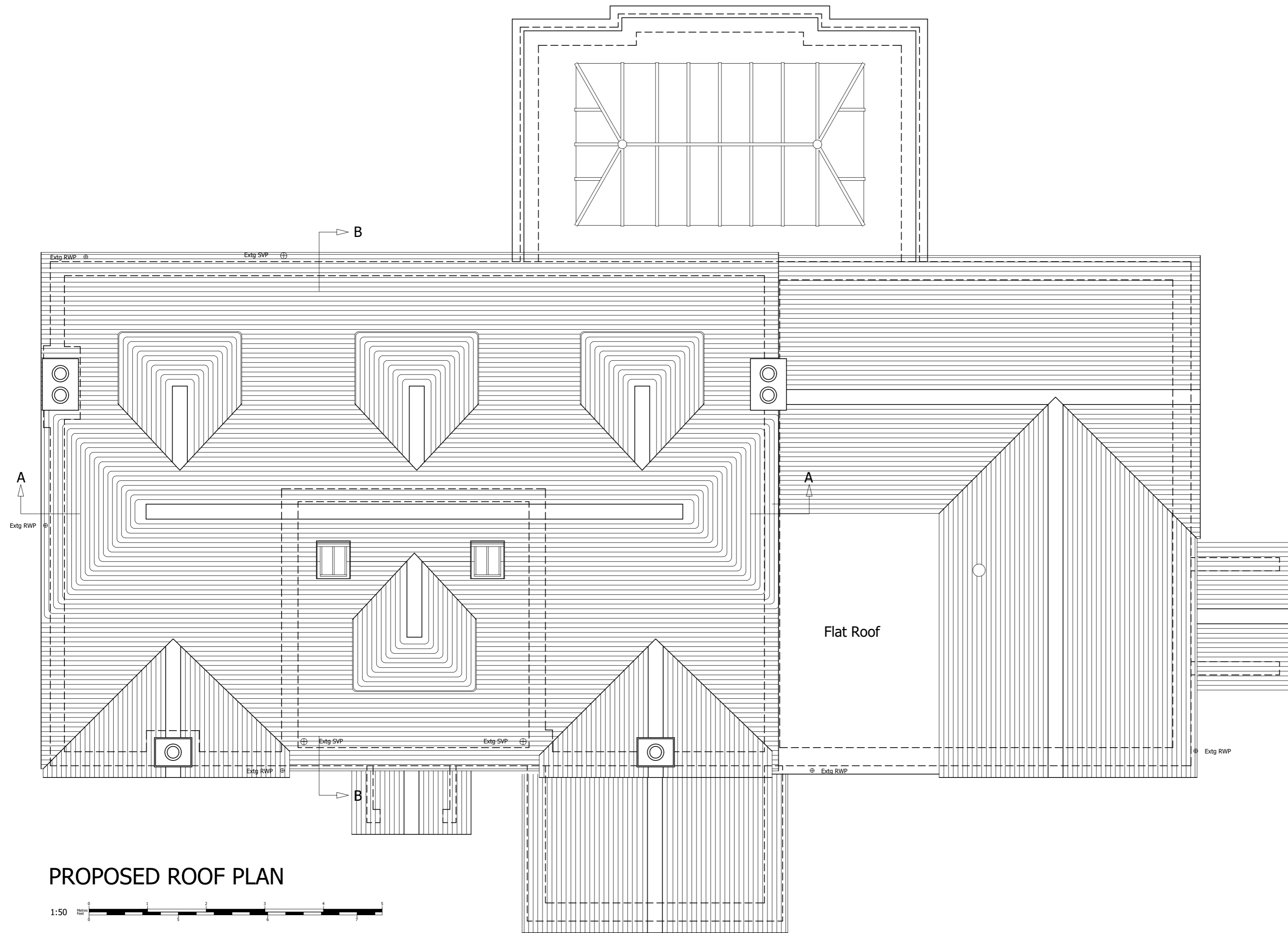
